Order Calling Election of Trustees for the El Paso Independent School District

ORDER CALLING ELECTION OF TRUSTEES OF THE EL PASO INDEPENDENT SCHOOL DISTRICT

WHEREAS, it is necessary that an election be held within the El Paso Independent School District (the "District") for the purpose of electing four (4) Trustees to the Board of Trustees of the District, with said election to be held pursuant to Section 11.052, and other pertinent provisions, of the Texas Education Code and Texas Election Code:

THEREFORE, BE IT RESOLVED AND ORDERED by the Board of Trustees of the District the following:

- (1) That there be and there is hereby called to be held on May 1, 2021, during the hours prescribed by law (7:00 a.m. to 7:00 p.m.), within the District, an election at which there shall be elected four (4) Trustees to the Board of Trustees to be elected for a designated position in the designated district as hereinafter specifically set forth;
- (2) That a Trustee shall be elected, by position, from each of the following four (4) singlemember districts and the voting shall be accomplished in the respective precincts at the following identified polling places and addresses:

The Position (District) 1 Trustee shall be elected to a four-year term from the following numbered county election precincts: 25, 30-42. The voting shall be accomplished at the voting centers established by the El Paso County Elections Department (the "Department") and listed in Exhibit "A" attached hereto.

The Position (District) 3 Trustee shall be elected to a four-year term from the following numbered county election precincts: 67-75, 86-88, 127, 187, and 188. The voting shall be accomplished at the voting centers established by the Department and listed in Exhibit "A" attached hereto.

The Position (District) 4 Trustee shall be elected to a four-year term from the following numbered county election precincts: 57, 59-66, 185, and 186. The voting shall be accomplished at the voting centers established by the Department and listed in Exhibit "A" attached hereto.

The Position (District) 5 Trustee shall be elected for a four-year term from the following numbered county election precincts: 43-48, 51-53, 55, 56, 184, and 194. The voting shall be accomplished at the voting centers established by the Department and listed in Exhibit "A" attached hereto.

- (3) That early voting by personal appearance shall take place at the main early voting polling place, El Paso County Courthouse, 500 East San Antonio, El Paso, Texas, 79901, during the hours of 8:00 a.m. to 5:00 p.m.; and also at such other branch early voting polling places as may be maintained by the El Paso County Elections Administrator (the "Administrator") in this Joint Election. Early voting by personal appearance shall take place on the dates and during the hours required by law, and at such additional dates and hours as may be maintained by the Administrator, during the period commencing April 19 and ending April 27, 2021. The Board authorizes the Interim Superintendent to make such changes to the polling places, dates and hours for early voting as may be recommended by the Administrator and authorized by law.
- (4) That early voting ballots may be voted by mail, pursuant to Chapter 86 of the Texas Election Code. Mail applications for an early voting ballot should be addressed to the Early Voting Clerk, Lisa Wise, at the Office of the County Elections Administrator, 500 E. San Antonio, #314, El Paso, Texas 79901. The deadline for receipt by the Administrator of an application for an early voting ballot to be voted by mail shall be April 20, 2021, as determined by Section 84.007 of the Texas Election Code. Late ballot voting shall be conducted pursuant to Chapters 102 and 103 of the Texas Election Code.
- (5) That the Interim Superintendent of the District, and designees, are hereby appointed to hold such election, to provide all necessary facilities for the holding and conduct thereof, and generally to care for and arrange all details of said election, including the selection, replacement and/or substitution of election personnel, to the extent not specifically appointed herein, and subject to the Contract for Election Services to be entered into with the El Paso County. Qualified judges and clerks will be used in the election. No employees of the District will serve as an election official. A Central Counting Station shall be used for the election. Precinct judges, and certain other election personnel, are appointed as stated on Exhibit "B" attached hereto, and as stated in the Contract to be entered into with the El Paso County. The persons authorized to provide for and conduct said elections shall make all necessary instructions therefor.
- (6) That those persons desiring to become candidates at said election shall, not later than the twelfth (12th) day of February, 2021, at 5:00 p.m., and not earlier than the thirteenth (13th) day of January, 2021, file their written applications for candidacies for office with the Secretary of the Board, or the Interim Superintendent of the District or designee, in the office of the Interim Superintendent of the District, at the Administrative Offices of the District, 1014 N. Stanton St., El Paso, Texas, 79902, pursuant to Texas Education Code § 11.055. NOTE: Said office shall be open Monday through Friday during the filing period during regular business hours (8:00 a.m. to 4:30 p.m.), except that it shall be open until 5:00 p.m. on February 12, 2021. Each candidate must specify in each instance the number of the district for which the applicant is filing as a candidate and no candidate may file for more than one position to be filled at this election. Each candidate must be a resident of the single-member district within the District which the candidate seeks to represent and

- must be a qualified voter and otherwise qualified to hold the position of Trustee of a public independent school district under Texas law.
- (7) That ballots conforming to the requirements of the law of the State of Texas shall be prepared with the names, without titles, of all candidates, and that said ballots shall be provided by the persons above appointed to hold said elections and shall be distributed in due time to the judges holding said elections, together with the necessary voter registration lists showing voters qualified to vote within the voting precincts of the District. All such resident, qualified voters of the District shall be entitled to vote in the election. The electronic or touch-screen voting system used by the County of El Paso is hereby adopted by the District for use in the election.
- (8) That candidates who have filed applications to have their names appear on said ballot will meet at the Board Room of the EPISD Education Center Stanton Building, 1014 N. Stanton St., El Paso, Texas, 79902, at 9:00 a.m. on Monday, the 22th day of February, 2021 (or as soon thereafter as they may meet, at the call of the Interim Superintendent or designee), for the ballot order drawing in accordance with law, and, by a drawing pursuant to Texas Election Code § 52.094, determine the order in which their respective names shall appear on said ballot. Notice of the drawing shall be posted and mailed in accordance with Texas Election Code § 52.094 (c) and (d). No person shall be permitted to have his or her name appear on said ballot as a candidate until he or she has filed with the Interim Superintendent or Secretary of this Board (or designee) a loyalty affidavit, as required by Section 141.031 of the Texas Election Code. The form of the affidavit required is included within the prescribed form of the Application for a Place on the General Election Ballot, available in the office of the Interim Superintendent of the District. Write-in candidacies shall also be permitted, pursuant and subject to Texas Education Code § 11.056.
- (9) That this election shall be combined with other elections to be held on the same date. That the President of this Board of Trustees be and is hereby authorized to execute an Interlocal Agreement for a Joint Election with the El Paso Community College pursuant to, and meeting the requirements of, Chapter 271 of the Texas Election Code, and Section 11.0581 of the Education Code. That the President of this Board of Trustees be and is hereby authorized to execute a Contract for Election Services with the El Paso County Elections Administrator regarding the operation and cost of this Board of Trustees election.
- (10) That notice of the election and copy of this Order shall be posted on the bulletin board used for posting notices of meetings of the Board of Trustees, not later than April 10, 2021, and shall remain posted continuously through election day, pursuant to Tex. Election Code § 4.003. Notice of the election, including the location of each polling place and the hours the polls will be open, shall also be published, not earlier than April 1, 2021, and not later than April 21, 2021, in a newspaper published within the District, pursuant to Texas Election Code § 4.003. Notice of the election shall be delivered to the County Clerk of El Paso County not later than March 3, 2021, pursuant to Texas Election Code § 4.008.

- (11) That said elections shall be held and returns thereof made to the Board of Trustees of the District in accordance with the general election laws, and that said Board of Trustees shall canvass such returns, declare the results of such elections, and issue certificates of such elections to the persons shown by such returns to have been elected.
- (12) The candidate receiving the majority of votes in each single-member district shall be elected to the corresponding Trustee position. If no candidate for a position receives a majority of the votes cast for that position, the Board will order a runoff election for such position, between the two persons receiving the highest number of votes for that position, in accordance with Texas Education Code § 11.057(c) and Subchapter B of Chapter 2 of the Texas Election Code.
