

A RESOLUTION ORDERING A SPECIAL ELECTION BY THE QUALIFIED VOTERS OF THE TOWN OF HORIZON CITY, TEXAS ON SATURDAY, MAY 6, 2023, FOR THE PURPOSE OF ELECTING A CITY COUNCIL MEMBER PLACE 4 FOR AN UNEXPIRED TERM EXPIRING IN MAY OF 2025.

WHEREAS, a vacancy has occurred on the City Council of Town of Horizon City for Place Number 4 with an unexpired term ending in May 2025;

WHEREAS, the City Council has ordered a general election to be held on Saturday, May 6, 2023, for the purpose of electing the Mayor and City Council members, Places 3, 5 and 7; and

WHEREAS, the City Council desires to call a special election on Saturday, May 6, 2023, for the purpose of filling the vacancy in City Council Place 4.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE TOWN OF HORIZON CITY:

SECTION I.

That in compliance and accordance with the laws and constitution of the State of Texas, a s special election shall be and the same is hereby called and ordered for Saturday, May 6, 2023, for the purpose of electing a City Council Member for Place 4, together with the general election that has already been ordered for election of the Mayor and City Council members places 3,5 and 7.

SECTION II.

The City Clerk, together with the El Paso County Elections Administrator, shall cause the official ballot to be prepared to be used in said special election, and the Place for the Council member shall be designated on the official ballot as Place 4.

SECTION III.

That no person's name shall be placed upon the official ballot as a candidate for the position of City Council Member Place 4 unless such person has filed his sworn application, in compliance with and as provided by the laws of Texas, no later than March 6, 2023 at 5:00 p.m., and the designation of the number of Place 4 on the City Council that said candidate is seeking must appear on the face of said application.

SECTION IV.

That the polls shall be kept open from 7:00 a.m. until 7:00 p.m. on the day of the election, and at such election, all qualified voters in the Town are authorized to vote for his or her choice of candidate for each place and shall vote for one candidate only for each place, with the due return being made to the Council showing the number of votes cast for each candidate for each of the positions of Council Members.

SECTION V.

That Lisa Wise, County Elections Administrator, shall be the early voting clerk for said election. The County Courthouse, 500 E. San Antonio, El Paso, Texas, is hereby designated as the main early voting polling place for said election. In addition, early voting may also occur at such branch early voting polling places as are designed herein or otherwise designated by the El Paso County Elections Administrator and for which notice is given, and early voting on Saturday and Sunday is ordered. The City Clerk is authorized to revise or add exhibits to this Resolution and to the Order of Election designating these early voting locations and times for voting as are established or revised by the El Paso County Elections Administrator.

Applications for ballot by mail shall be submitted to the Early Voting Clerk: 500 E. San Antonio, Lower Level, Ste. L115, El Paso, TX 79901, no later than the close of regular business in the Early Voting Clerk's office, or 12 noon, whichever is later on the **11th day** before the date of the Election or as may otherwise be required by law.

SECTION VI.

That a candidate who receives a majority of all the votes cast for the office for which he or she is a candidate shall be elected for such office. In the event of a tie, the provisions of Section 2.002 of the Texas Election Code, or other applicable state statute dealing with a "Tie Vote", shall be followed. If a runoff election is required to elect an officer by a majority vote, it shall be held on a date as permitted by the Texas Election Code. Such election, if any, shall be called by the City Council. Early voting dates and sites will be identified if such runoff election shall be held.

SECTION VII.

That electronic voting machines, as certified for use by the El Paso County Elections Administrator, shall be used for voting at the regular polling places in such election, and for the casting of early ballots by persons voting early by personal appearance.

SECTION VIII.

That this Resolution, signed by the Mayor and attested by the City Clerk, shall constitute the proclamation of the Mayor calling and ordering said election, and that the City Clerk is directed to prepare the appropriate notice of election containing the directives of this Resolution and the Order of Election, as required by the Texas Election Code. The City Clerk shall give notice of such election in English and Spanish by posting such notice at the Town Hall and by publishing a copy of such notice in a newspaper as required by law.

SECTION IX.

The City Clerk shall deliver notice of this special election to the county clerk and voter registrar of El Paso County as required by law, not later than Tuesday, March 7, 2023.

SECTION X.

That the polling places located in the Town of Horizon City for this election shall at a minimum be as follows:

Pursuant to Section 43.007 of Texas Election Code, the County of El Paso has established a countywide polling place program and voters may vote at any of the Polling Places designated by the El Paso County Elections Administrator pursuant to state law, the locations of which are attached here as Exhibit A and incorporated into this Resolution by reference as if expressly set forth herein.

SECTION XI.

Early voting by personal appearance will be conducted on the following days and times:

From Monday, April 24, 2023 through Friday, April 28, 2023, from 8:00 a.m. to 5:00 p.m.

On Saturday, April 29, 2023, from 7:00 a.m. to 7:00 p.m.

On Sunday, April 30, 2023, from 12:00 p.m. (noon) to 5:00 p.m.

On Monday, May 1, 2023 and Tuesday, May 2, 2023, from 7:00 a.m. to 7:00 p.m. (designated dates for extended hours)

In addition to the main early voting location designated by the Early Voting Clerk, early voting by personal appearance will be conducted at the early voting location in Horizon City, at:

OZ GLAZE SENIOR CENTER, 13969 Veny Webb, Horizon City, Texas,

and at any other place as shall be designated by the County Elections Administrator and for which notice is given by the City Clerk.


SECTION XIII.

This Resolution was duly adopted with all the requisites and formalities incident thereto the adoption of resolutions and as such is evidenced by the below signatures, and further that the foregoing recitals are incorporated into this Resolution by reference as findings of fact as if expressly set forth herein. By approving and signing this Resolution, the Mayor officially certifies and confirms as his action, all matters recited herein which by law come within his jurisdiction.






