All members of the Board were present with the exception of Director Lascurain and Director Treviño, thus constituting a quorum, and among other proceedings had by said Board of Directors was the following:

There came on to be considered the election of three (3) directors each of whom shall serve four (4) year terms which was called to be held on May 6, 2023 and the certification, attached as **Exhibit "A"** to this Order, submitted by the Secretary of the District that:

- (1) The election order entered by the District on February 9, 2023 stated that ballots used in the election shall have printed thereon the names of all candidates for the office of director who filed applications to have their names printed on the ballot by 5:00 p.m. seventy-one (71) days prior to the election, and blank spaces for write-in votes. The order further stated that any persons interested in applying to be a candidate for the office of director may obtain an application to have their names printed on the ballot at the offices of the District, Inframark, LLC, 13034 Eastlake Boulevard, Suites D-E, El Paso, Texas 79928, and at the offices of the District's General Counsel, Lloyd Gosselink Rochelle & Townsend, P.C., 816 Congress Avenue, Suite 1900, Austin, Texas 78701.
- (2) February 17, 2023 at 5:00 p.m. was the deadline for persons to file an application to have their name printed on the ballot and February 21, 2023 at 5:00 p.m. was the deadline for write-in candidates to file a declaration of write-in candidacy.

- (3) The only person who has filed an application to have his name placed on the ballot is Jose R. Soto.
- (4) Three (3) positions for the office of director are scheduled to be voted on at the May 6, 2023 election and only one person has filed an application to have his name placed on the ballot; therefore, only one (1) candidate's names is to be placed on the ballot.
- (5) No person has filed a declaration of write-in candidacy for the May 6, 2023 election; therefore, no candidate's name is to be placed on a list of write-in candidates for the office of director.
- (6) Candidate Jose R. Soto is unopposed for election to the office of director.

IT IS THEREFORE, FOUND AND DECLARED AND SO ORDERED by the Board of Directors of Paseo del Este Municipal Utility District No. 11 that the above Directors Election was duly called; that the Secretary of the District has duly certified in writing that Jose R. Soto is unopposed for election to the office of director in accordance with law; that Jose R. Soto is declared elected to serve a four-year term on the Board of Directors of said District, subject to his taking his oath, executing and filing his bond as required by law; the election called for May 6, 2023 will not be held, and a copy of the Order of Cancellation, attached as **Exhibit "B,"** declaring the candidates elected shall be posted in English and Spanish at the polling place located at Horizon Heights Elementary School, 13601 Ryderwood Avenue, El Paso, Texas 79928, on May 6, 2023.

It is further found and determined that notice of the date, place and subject of this meeting was posted in accordance with the terms and provisions of V.C.T.A., Government Code § 551 at least 72 hours preceding the scheduled time of this meeting and that the terms and provisions of said V.C.T.A., Government Code § 551 have been complied with.
