

ORDER FOR ELECTION OF TRUSTEES OF THE YSLETA INDEPENDENT SCHOOL DISTRICT

WHEREAS, it is necessary that an election be held within the Ysleta Independent School District for the purpose of electing three (3) Trustees to the Board of Trustees of the Ysleta Independent School District, with said election to be held pursuant to Section 11.052, and other pertinent provisions, of the Texas Education Code (and Texas Election Code):

THEREFORE, BE IT RESOLVED AND ORDERED by the Board of Trustees of the YSLETA INDEPENDENT SCHOOL DISTRICT the following:

- (1) That there be and there is hereby called to be held on May 6, 2023, during the hours prescribed by law (7:00 a.m. to 7:00 p.m.), within the YSLETA INDEPENDENT SCHOOL DISTRICT, an election at which there shall be elected three (3) Trustees to the Board of Trustees to be elected for a designated position in the designated district as hereinafter specifically set forth;
- (2) That a Trustee shall be elected, by position, from each of the following three (3) single-member districts and the voting shall be accomplished in the respective precincts at the following identified polling places and addresses:

The Position (District) 2 Trustee shall be elected to a four-year term from the following numbered county election precincts, and the voting shall be accomplished at any voting center shown in exhibit A and B.

District 2 precincts: 104, 137, 138, 139, 140, 144, portion of 103, and a portion of 141

The Position (District) 4 Trustee shall be elected to a four-year term from the following numbered county election precincts, and the voting shall be accomplished at any voting center shown in exhibit A and B.

District 4 precincts: 93, 94, 95, 96, 97, 98, 99, 175, and portion 103

The Position (District) 6 Trustee shall be elected to a four-year term from the following numbered county election precincts, and the voting shall be accomplished at any voting center shown in exhibit A and B.

District 6 precincts: 148, 149, 150, 151, 179, portion 153, portion 156, portion 157

The Ysleta Independent School District Board of Trustees finds that such county election precincts as designated above have previously been served by common polling places by the County of El Paso, and that said common polling places for the said county election precincts can adequately and conveniently serve any voter and will facilitate the orderly conduct of this Joint Election with the El Paso Community College District, pursuant to Tex. Election Code § 271.003.

- (3) That early voting by personal appearance shall take place at the main early voting polling place, Third Floor, El Paso County Courthouse, 500 East San Antonio, during the hours of 8:00 a.m. to 5:00 p.m.; and also at such other branch early voting polling places as may be maintained by the County Elections Administrator in this Joint Election. Early voting by personal appearance shall take place on the dates and during the hours required by law, and at such additional dates and hours as may be maintained by the County Elections Administrator, during the period commencing April 24, 2023, as reflected by Schedule "A" and Schedule "B" attached hereto. The Board authorizes the Superintendent to make such changes to the polling places, dates and hours for early voting as may be recommended by the County Elections Administrator and authorized by law.
- (4) That early voting ballots may be voted by mail, pursuant to Chapter 86 of the Texas Election Code. Applications for an early voting ballot may be submitted by U.S. mail addressed to the Early Voting Clerk, Lisa Wise, at the Office of the County Elections Administrator, 500 E. San

Antonio, Suite 314, El Paso, Texas 79901, or may be submitted by email to ballotrequests@epcounty.com. The deadline for receipt by the County Elections Administrator of an application for an early voting ballot to be voted by mail shall be April 25, 2023, as determined by Section 84.007 of the Texas Election Code. Late ballot voting shall be conducted pursuant to Chapters 102 and 103 of the Texas Election Code.

- (5) That the Superintendent of the Ysleta Independent School District, and designees, are hereby appointed to hold such election, to provide all necessary facilities for the holding and conduct thereof, and generally to care for and arrange all details of said election, including the selection, replacement and/or substitution of election personnel, to the extent not specifically appointed herein, and subject to the Contract for Election Services to be entered into with the El Paso County Elections Department. Qualified judges and clerks will be used in the election. No employees of the YSLETA INDEPENDENT SCHOOL DISTRICT will serve as an election official. A Central Counting Station shall be used for the election. Precinct judges, and certain other election personnel, are appointed as stated on Schedule "C" attached hereto, and as stated in the Contract to be entered into with the El Paso County Elections Department. The persons authorized to provide for and conduct said elections shall make all necessary instructions therefor.
- (6) That those persons desiring to become candidates at said election shall, not later than the seventeenth (17th) day of February, 2023, at 5:00 p.m., and not earlier than the eighteenth (18th) day of January, 2023, file their written applications for candidacies for office with the Secretary of the Board, or Superintendent of the YISD or designee, in the office of the Superintendent of the YISD, at the Administrative Offices of the Ysleta Independent School District, 9600 Sims, El Paso, Texas, pursuant to Tex. Educ. Code § 11.055. A completed application by mail, fax 915-591-4144, or email to mmatthewson@yisd.net, must be received by the deadline. Each candidate must specify in each instance the number of the district for which the applicant is filing as a candidate and no candidate may file for more than one position to be filled at this election. Each candidate must be a resident of the single-member district within the YSLETA INDEPENDENT SCHOOL DISTRICT which the candidate seeks to represent and must be a qualified voter and otherwise qualified to hold the position of Trustee of a public independent school district under Texas law.
- (7) That ballots conforming to the requirements of the law of the State of Texas shall be prepared with the names, without titles, of all candidates, and that said ballots shall be provided by the persons above appointed to hold said elections and shall be distributed in due time to the judges holding said elections, together with the necessary voter registration lists showing voters qualified to vote within the applicable voting precincts of the YSLETA INDEPENDENT SCHOOL DISTRICT. All such resident, qualified voters of the applicable single-member districts within the District shall be entitled to vote in the election. The electronic or touch-screen voting system used by the County of El Paso, accessible to voters with physical disabilities as required by law, is hereby adopted by the District for use in the election.
- (8) That candidates who have filed applications to have their names appear on said ballot will meet at the Rio Grande Room of the YISD, 9600 Sims, El Paso, Texas, at 5:15 p.m. on Monday, the 27th day of February, 2023 (or as soon thereafter as they may meet, at the call of the Superintendent or designee), for the ballot order drawing in accordance with law, and, by a drawing pursuant to Texas Election Code § 52.094, determine the order in which their respective names shall appear on said ballot. Notice of the drawing shall be posted and mailed in accordance with Texas Election Code § 52.094 (c) and (d). No person shall be permitted to have his or her name appear on said ballot as a candidate until he or she has filed with the Superintendent or Secretary of this Board (or designee) a loyalty affidavit, as required by Section 141.031 of the Texas Election Code. The form of the affidavit required is included within the prescribed form of the Application for a Place on the General Election Ballot, available in the office of the Superintendent of the YISD. Write-in candidacies shall also be permitted, pursuant and subject to Texas Education Code § 11.056.

- (9) That notice of the election and copy of this Order shall be posted on the bulletin board used for posting notices of meetings of the Board of Trustees, not later than April 15, 2023, and shall remain posted continuously through election day, pursuant to Tex. Election Code § 4.003. Notice of the election, including the location of each polling place and the hours the polls will be open, shall also be published in the newspaper and posted on the District's Internet website not earlier than April 6, 2023, and not later than April 26, 2023, pursuant to Tex. Election Code § 4.003. Notice of the election shall be delivered to the County Clerk and County Elections Administrator/Voter Registrar of El Paso County not later than March 7, 2023, pursuant to Tex. Election Code § 4.008.
- (10) That said elections shall be held and returns thereof made to the Board of Trustees of the YSLETA INDEPENDENT SCHOOL DISTRICT in accordance with the general election laws, and that said Board of Trustees shall canvass such returns, declare the results of such elections, and issue certificates of such elections to the persons shown by such returns to have been elected.
- (11) The candidate receiving the majority of votes in each single-member district shall be elected to the corresponding Trustee position. If no candidate for a position receives a majority of the votes cast for that position, the Board will order a runoff election for such position, between the two persons receiving the highest number of votes for that position, in accordance with Tex. Educ. Code § 11.057(c) and Subchapter B of Chapter 2 of the Texas Election Code.

ORDEN DE ELECCIÓN DE SÍNDICOS DEL DISTRITO ESCOLAR INDEPENDIENTE DE YSLETA

Considerando que siendo necesario que se lleve a cabo una elección dentro del Distrito Escolar Independiente de Ysleta con el propósito de elegir a tres (3) síndicos para el Consejo Directivo del Distrito Escolar Independiente de Ysleta, y dicha elección será celebrada conforme al artículo 11.052, y otras normas del Código de Educación de Texas (y el Código Electoral de Texas):

Por lo tanto, sea resuelto y ordenado por el Consejo Directivo del Distrito Escolar Independiente de Ysleta lo siguiente:

- (1) Que por medio de la presente sea convocado a llevarse a cabo el 6 de mayo de 2023 durante las horas prescritas por la ley (7:00 a.m. a 7:00 p.m.), dentro del Distrito Escolar Independiente de Ysleta, una elección en la cual serán elegidos tres (3) síndicos para el Consejo Directivo a ser elegidos para un cargo designado, en el distrito designado, y específicamente establecido a continuación;
- (2) El síndico será elegido, por cargo, de cada uno de los siguientes tres (3) distritos de un solo miembro y la votación será realizada en el recinto correspondiente en los siguientes centros de votación y domicilios identificados:

El cargo de Síndico (distrito) 2, será elegido a un periodo de cuatro (4) años de los siguientes distritos electorales del condado, y la votación será realizada en cualquiera de los centros de votación mostrado en el anexo A y B.

Distrito Electoral 2: 104, 137, 138, 139, 140, 144, parte de 103, y parte de 141

El cargo de Síndico (distrito) 4, será elegido a un periodo de cuatro (4) años de los siguientes distritos electorales del condado, y la votación será realizada en cualquiera de los centros de votación mostrados en el anexo A y B.

Distrito Electoral 4: 93, 94, 95, 96, 97, 98, 99, 175, y parte de 103

El cargo de Síndico (distrito) 6, será elegido a un periodo de cuatro (4) años de los siguientes distritos electorales del condado, y la votación será realizada en cualquiera de los centros de votación mostrados en el anexo A y B.

Distrito Electoral 6: 148, 149, 150, 151, 179, y parte de 153, y parte de 156, y parte de 157

El Distrito Escolar Independiente de Ysleta afirma que dichos distritos electorales del condado, conforme han sido nombrados anteriormente, han sido utilizados previamente como centros de votación frecuentes por el Condado de El Paso, y que dichos centros de votación frecuentes para dichos distritos electorales del condado pueden servir con eficiencia y comodidad a cualquier elector y facilitará una realización ordenada de esta elección conjunta con el Distrito de El Paso Community College, conforme al Código Electoral de Texas § 271.003.

- (3) La votación anticipada por comparecencia personal se llevará a cabo en el centro de votación principal, 3er piso de la Corte del Condado de El Paso, 500 East San Antonio, durante las horas de 8:00 a.m. a 5:00 p.m.; al igual que en las sucursales de centros de votación anticipada como son elegidas en esta elección conjunta por el Administrador de Elecciones del Condado. Votación anticipada por comparecencia personal se llevará a cabo en las fechas y durante las horas requeridas por ley y en fechas y horas adicionales como sea establecido por el Administrador de Elecciones del Condado durante el periodo que inicia el 19 de abril y termina el 24 de abril de 2023, como se refleja en el apéndice "A" y apéndice "B" adjunto. El Consejo le autoriza al Superintendente hacer cambios a los centros de votación, fechas y horas para la votación anticipada, conforme sea recomendado por el Administrador de Elecciones del Condado y como lo autoriza la ley.

- (4) Las boletas de votación anticipada pueden ser emitidas por correo, conforme al capítulo 86 del Código Electoral de Texas. Las solicitudes para una boleta de votación anticipada pueden ser enviadas por correo al Secretario de Votación Anticipada, Lisa Wise, en la oficina del Administrador de Elecciones del Condado, 500 E. San Antonio, Suite 314, El Paso, Texas 79901, o puede ser enviada por correo electrónico a ballotrequests@epcounty.com. El último día para solicitar una boleta de votación anticipada del Administrador de Elecciones del Condado para ser emitida por correo será el 25 de abril de 2023, según lo establece el Código Electoral de Texas 84.007. La votación con boleta tardía se llevará a cabo de conformidad con los Capítulos 102 y 103 del Código Electoral de Texas.
- (5) Que el Superintendente del Distrito Escolar Independiente de Ysleta y sus designados quedan nombrados para llevar a cabo dicha elección, proporcionar todos los servicios necesarios para la participación y realización de la misma, y en general cuidar y organizar todos los detalles de dicha elección, incluyendo la selección, reemplazo y/o sustitución de personal electoral en la medida en que no ha sido indicada expresamente en el presente documento y sujeta al Contrato de Servicios Electorales suscrito con el Departamento de Elecciones del Condado de El Paso. Se usará a jueces y funcionarios cualificados en la elección. Ningún empleado del Distrito Escolar Independiente de Ysleta desempeñará el papel de funcionario electoral. Se utilizará una estación central de recuento en la elección. Jueces electorales y personal electoral son nombrados según lo indicado en el apéndice C adjunto, y de acuerdo con el Contrato suscrito con el Departamento de Elecciones del Condado de El Paso. Las personas autorizadas para posibilitar y llevar a cabo dichas elecciones proporcionarán todas las instrucciones necesarias correspondientes.
- (6) Aquellas personas que deseen ser candidatos en dicha elección deberán, a más tardar del duodécimo (17) día de febrero de 2023, a las 5:00 p.m., y no antes del decimotercer (18) día de enero de 2023, presentar su petición escrita para su candidatura con el Secretario del Consejo Directivo, o Superintendente del Distrito de Ysleta o su designado, en la oficina del Superintendente de YISD, en las oficinas administrativas del Distrito Escolar Independiente de Ysleta, 9600 Sims, El Paso, Texas, de acuerdo con el Código de Educación de Texas § 11.055. Una solicitud completa, enviada por correo, fax 915-591-4144, o correo electrónico a mmathewson@yisd.net, debe ser recibida dentro del plazo límite. Cada candidato debe especificar en cada petición el número del distrito para el cual se presenta como candidato y ningún candidato puede aplicar para más de un cargo a cubrir en esta elección. Cada candidato debe ser residente del distrito de un solo miembro dentro del DISTRITO ESCOLAR INDEPENDIENTE DE YSLETA para el cual el candidato desea representar, y debe ser un votante calificado y competente para ocupar el cargo de Síndico en un distrito escolar independiente público bajo la ley de Texas.
- (7) Las boletas que cumplen con los requisitos de la ley del Estado de Texas serán preparadas con los nombres, sin títulos, de todos los candidatos y dichas boletas serán proporcionadas por las personas designadas para llevar a cabo dichas elecciones y serán distribuidas oportunamente a los jueces que llevarán a cabo dichas elecciones, junto con la lista del censo electoral que muestra los votantes calificados para votar dentro de los distritos electorales del DISTRITO ESCOLAR INDEPENDIENTE DE YSLETA. Todos los electores residentes del distrito de un solo miembro aplicable dentro del Distrito tendrán derecho a votar en la elección. El sistema de votación electrónica o de pantalla táctil utilizado por el Condado de El Paso y accesible para los electores con discapacidades físicas, como lo requiere la ley, ha sido adoptado por el Distrito Escolar Independiente de Ysleta para uso en esta elección.
- (8) Los candidatos que han presentado solicitudes para que sus nombres aparezcan en la boleta se reunirán en la sala de juntas Rio Grande del Distrito de Ysleta, 9600 Sims, El Paso, Texas, a las 5:15 p.m., el lunes, 27 de febrero de 2023 (o tan pronto como se reúnan al ser convocados por el Superintendente o designado) para el sorteo de la orden de votación en cumplimiento con la ley y un sorteo conforme al Código Electoral de Texas § 52.094, y determinar el orden en el que aparecerán sus respectivos nombres en la boleta. Aviso del sorteo será publicado y enviado por correo conforme a el Código Electoral de Texas § 52.094 (c) y (d). No se permitirá a ninguna persona que su nombre aparezca en dicha boleta como candidato hasta que él/ella haya presentado

con el Superintendente o el Secretario del Consejo (o designado) su declaración jurada como lo requiere la artículo 141.031 del Código Electoral de Texas. El formulario de la declaración requerido está incluido en el formulario obligatorio de la solicitud para ser colocado en la boleta, disponible en la oficina del Superintendente de YISD. Candidaturas por escrito también serán permitidas, de conformidad y con sujeción al Código de Educación de Texas § 11.056.

- (9) Notificación de la elección y una copia de esta Orden será publicada en el tablero de anuncios utilizado para publicar avisos de juntas del Consejo Directivo, y en la página web del Distrito, a más tardar el 15 de abril de 2023, y permanecerá publicado de manera continua hasta el día de las elecciones, conforme a el Código Electoral de Texas § 4.003. Notificación de la elección, incluyendo la ubicación de cada centro de votación y el horario de los centros de votación serán publicados, también se publicará en el periódico y en el sitio web de Internet del Distrito a más tardar el 6 de abril de 2023 y a más tardar el 26 de abril de 2023, de conformidad con el Código Electoral de Texas § 4.003. Notificación de la elección será entregada al Secretario del Condado y al Administrador de Elecciones del Condado/Funcionario de Registro de Electores del Condado de El Paso a más tardar del 7 de marzo de 2023, conforme a el Código Electoral de Texas § 4.008.
- (10) Que dichas elecciones se realizarán y devolución de las mismas se harán al Consejo Directivo del DISTRITO ESCOLAR INDEPENDIENTE DE YSLETA en cumplimiento con las leyes electorales generales, y que el Consejo Directivo realizará el escrutinio de los votos, declarará los resultados de dichas elecciones y expedirá los certificados de dichas elecciones a las personas cuyos votos muestran haber sido elegidos.
- (11) El candidato que reciba la mayoría de los votos en cada distrito de un solo miembro será elegido al cargo de Síndico correspondiente. Si ningún candidato para un cargo recibe la mayoría de los votos emitidos para ese cargo, el Consejo ordenará una elección de desempate para dicho cargo, entre las dos personas que recibieron el mayor número de votos para ese cargo, conforme a el Código de Educación de Texas § 11.057(c) y Subcapítulo B del Capítulo 2 del Código Electoral de Texas.
